## FUND OBJECTIVE AND STRATEGY

### Investment objective

The Fund aims to provide current income, while seeking to maintain liquidity and a low volatility of principal

### Permissible investments

- Invests primarily in high-quality, short-term municipal obligations that generate interest income exempt from federal income taxes
- Investments include private activity and industrial development bonds, tax anticipation notes, municipal lease obligations and participations in pools of municipal obligations
- Creates a portfolio suitable for temporary or medium-term cash investments, cash sweeps or the cash component of an investment portfolio

### Fund highlights

- IM Shares of the Fund may only be purchased by investment companies, including the J.P. Morgan Funds, registered under the Investment Company Act of 1940, as amended (the 1940 Act) and/or their wholly-owned subsidiaries (collectively, funds).
- The Fund is designed for temporary or medium-term cash investments, seasonal operating cash, automated cash sweeps and the liquidity components of investment portfolios.
- The Fund aims to preserve capital, maintain liquidity and produce a competitive yield.

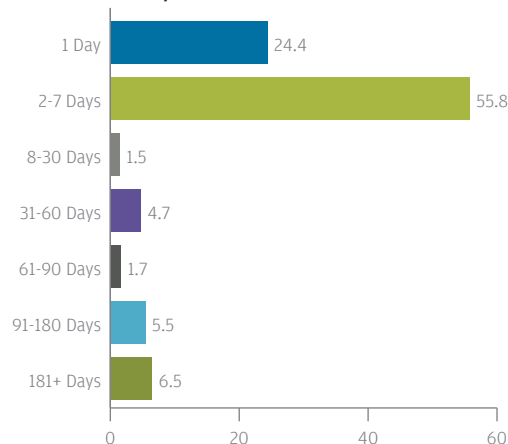

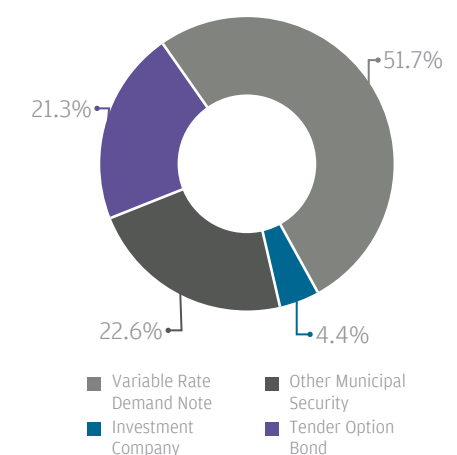
