I will contact J.P.Morgan Institutional Funds Service Center immediately if (i) I do not receive an online acknowledgment of an order transmitted electronically; or (ii) I do not receive a written confirmation of an order within five business days; or (iii) I believe there is a discrepancy between a transaction I performed and the online acknowledgment or written confirmation I receive; or (iv) someone has obtained unauthorized access to the account or PIN. I understand that online access will be suspended when an incorrect PIN is entered multiple times. In addition, JPM reserves the right to suspend online access at any time. I understand that I may suspend account access and online transaction capabilities at any time by calling J.P. Morgan Institutional Funds Service Center at 800-766-7722.
