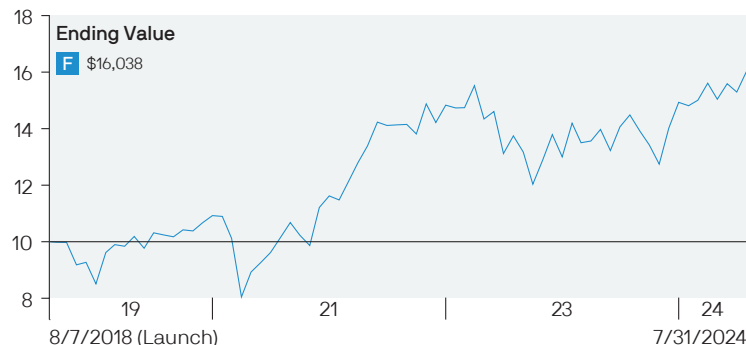

F2 Fund: Market price returns

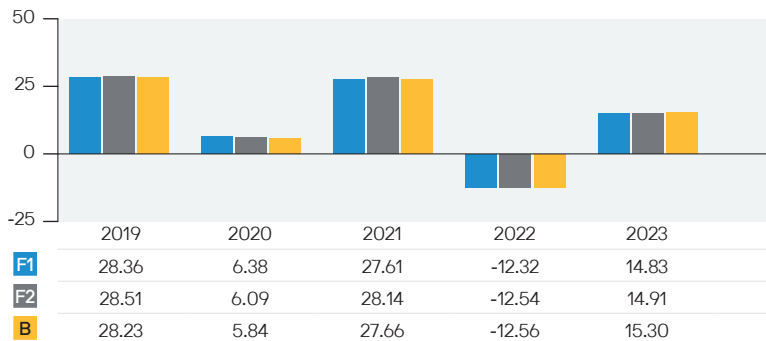
B Benchmark: Morningstar® Canada Target Market Exposure Index (net total return)
