

## INFORMATION REGARDING YOUR DECEMBER 16, 2024 DISTRIBUTIONS

### J.P. Morgan Exchange-Traded Funds

**DISTRIBUTION NOTICE** (December 16, 2024) – We are providing shareholders of the J.P. Morgan Exchange-Traded Funds (the “Funds”) in Appendix A with an estimate of the source of each Fund’s December 16, 2024 distributions per share (also listed in Appendix A) as required under applicable law. Each Fund estimates that its December 16, 2024 distribution is comprised in total of net profits from the sale of securities or other properties. This estimate is based on information as of December 16, 2024 and may change based on each Fund’s performance for the remainder of 2024. **THIS NOTICE IS NOT FOR TAX REPORTING PURPOSES AND IS BEING PROVIDED ONLY FOR INFORMATIONAL PURPOSES IN ORDER TO COMPLY WITH SECURITIES LAWS.** In February 2025, you will receive a Form 1099-DIV which will reflect the amount of income, capital gain and any return of capital paid by each Fund you own in calendar year 2024 and reportable on your 2024 federal and other income tax returns. Distributions by the Funds to retirement plans that qualify for tax-deferred treatment under federal income tax laws are not taxable; therefore, if you hold shares of the Funds in retirement plans that qualify for tax-deferred treatment under federal income tax laws, the information in this notice may not be relevant to your current tax situation.
