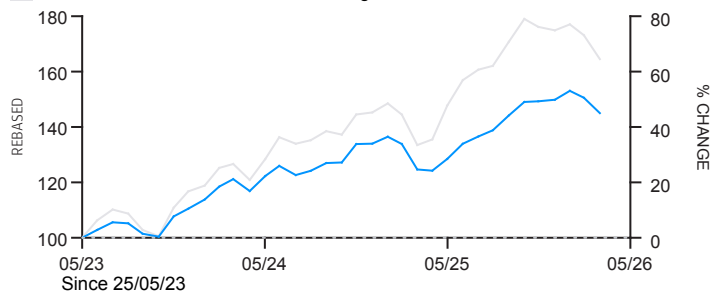

Definitions
