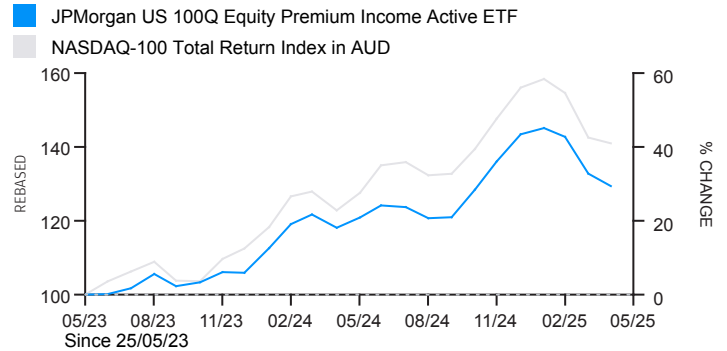
Investor Profile

Definitions
