If you send an application, withdrawal or transfer for a fund on any affected day above (or after the transaction cut-off time on the previous business day) your investment instruction will be processed as if it was received on the next business day.

For example, if you submit an investment instruction for the JPMorgan Global Strategic Bond Fund on 1st of Jan 2024 (or after the transaction cut-off time midday 29th Dec 2023) your transaction will be processed on 2nd of Jan 2024.
