JPMorgan Funds (Unit Trust Range)

India has had a longstanding non-resident capital gains tax ("CGT") regime whereby foreign portfolio investors such as the JPMorgan Funds (Unit Trust Range) ("the Funds") pay CGT on the gains realised on Indian securities depending on the length of holding period. Therefore, the Manager accrues for its best estimate of these taxes on a daily basis and this is reflected in the NAV.

The Indian Union Budget of 23 July 2024 proposed increases to the CGT rates. Although this has not yet been officially ratified by Parliament the increase in CGT rates would be effective from 23 July 2024.

As a result, the Manager has decided to effect these changes to the CGT rates in the calculation of the CGT accrual in the NAV of (i) JPMorgan India Fund and JPMorgan India Smaller Companies Fund (together, "India Funds"), and of (ii) Funds other than India Funds, from 6 August 2024 and 7 August 2024, respectively, on the basis that the amended rates reflect the best estimate of future taxes due on Indian equity holdings.
