Important: Notification for the Change of Transfer Agency Platform for J.P. Morgan Asset Management

Effective date: 25 May 2025

We would like to inform you about an upcoming transition of our transfer agency fund administration platform to another platform provided by our service provider, HSBC (the "Change"). The Change will take place on 25 May 2025 ("Effective Date").

The Change will not affect the ownership of your holdings or your funds' investment management. The costs of our transition, including those related to regulatory and investor communications, will be borne by J.P. Morgan Asset Management. Your account information such as your account number(s) will remain unchanged.

The Change will apply to the funds distributed in Hong Kong by JPMorgan Funds (Asia) Limited ("JPMFAL") including JPMorgan Funds (Unit Trust Range), JPMorgan SAR Funds, JPMorgan Provident Funds, JPMorgan Investment Funds (SICAV Range) and JPMorgan Funds (SICAV Range).

Important Updates Resulting from the Platform Transition:

1. Bank Account Details

Effective 25 May 2025, the bank account details for inward payments through Telegraphic/Bank Transfers for fund dealings will change from JPMorgan Chase Bank, N.A to entities within the HSBC group. Please refer to the new bank account details enclosed in this letter Appendix 1.

As such, all relevant forms containing bank account information will be updated accordingly. This includes the MasterAccount Application Form, which will be revised to reflect the new bank account details.

2. Transactions Involving Currency Conversion



For transactions involving currency conversion, a different conversion logic will be applied, as detailed below. You are advised to contact JPMFAL if you wish to pay for subscriptions in any other currencies or receive payment for redemptions in any other currencies or switching orders into units denominated in a different currency. In such cases, the costs of conversion into the currency in which the Fund or the Class is denominated will be charged and for subscription/redemption/switching orders by amount, the rate of conversion may be at the prevailing market rate as determined by the currency conversion service provider normally on the dealing day; for subscription/redemption/switching orders by number of units, the rate of conversion may be at the prevailing market rate as determined by the currency conversion service provider normally on the business day immediately after the dealing day. Please note that the process of determining the rate of conversion may differ depending on the type of orders and the fund (or share class) involved, please refer to the offering documents of the relevant funds for details.

This change in currency conversion handling will enable your transactions to be conducted on the spot as needed. There is no risk spread associated with such spot transactions.

#### 3. Client Documents

Investor documentations issued by JPMFAL will be reformatted but you will still have all the relevant information in the new document format provided to you.

For clients dealing directly with us on the J.P. Morgan DIRECT Investment Platform, please note that ePoints information will not be displayed on the eContract Note. Instead, you can log in to the J.P. Morgan DIRECT Investment Platform to access this information.

#### 4. Change of the Name of Party to be Credited for Regular Investment Plan

The changes below are applicable to clients maintaining a Regular Investment Plan with us.

The HKD beneficiary bank account name where your Regular Investment Plan payment is credited to will be changed from 'JPMorgan Funds (Asia) Limited RSP - Client Monies' to 'JPMFAL-INVSETT-CLIENT MONEY'. This change aligns with the bank account details for Telegraphic Transfers. It is important to note that the existing account number (i.e. 500422126003) will remain unchanged and will continue to be held with HSBC. There will be no change to the account holder of such existing account (JPMFAL remains the account holder). Additionally, your existing Regular Investment Plan will remain valid, and no action is required on your side.



All the key changes highlighted above will apply from the Effective Date of the Change.
