

Removal of benchmarks for certain Sub-Funds

JPMorgan Liquidity Funds

Due to the expected discontinuation of the current benchmarks, and the fact that the replacement benchmark options available are not deemed to be useful performance comparators in respect of how the Sub-Funds are managed, the benchmarks for the following Sub-Funds have been removed.
