Following a Share Class review and recent reductions to annual total expenses of certain Share Classes, we have decided to simplify our Share Class offering and provide certain shareholders with the benefits of expense reductions by merging certain Share Classes as follows:

- 1. The accumulating and distributing "Reserves" Share Classes in the Sub-Funds set out below in Table 1 will be merged into the equivalent "Morgan" Share Classes of that same Sub-Fund.
- 2. The accumulating "B" Share Class in the Sub-Funds set out below in Table 2 will be merged into the accumulating "A" Share Class of that same Sub-Fund.
- 3. The accumulating and distributing "R" Share Classes in the Sub-Funds set out below in Table 3 will be merged into the equivalent "C" Share Classes of that same Sub-Fund.

You do not need to take any action. You do however, have a variety of options all of which are explained below.

Defined terms have the same meaning as assigned to them in the Prospectus.

Impact of the mergers

On the Merger date, depending on which Share Class you are invested in, you will be impacted by the following Share Class mergers which will take place:

- Your "Reserves" shares will be exchanged automatically for shares in the equivalent "Morgan" Share Class resulting in a reduced annual total expense from 0.75% to 0.55%.
- Your "B" shares will be exchanged automatically for shares in the equivalent "A" Share Class resulting in no change to the annual total expense.
- Your "R" shares will be exchanged automatically for shares in the equivalent "C" Share Class resulting in no change to the annual total expense.
- All costs associated with the Share Class mergers will be borne by the Management Company, JPMorgan Asset Management (Europe) S.à r.l.

On the Merger date, you will not be able to subscribe for, switch or redeem shares in the "Reserves", "B" or "R" Share Classes.

Subscriptions into, switches or redemptions from the receiving "Morgan", "A" or "C" Share Classes will not be subject to any dealing restrictions.

If you are invested in a "(dist.)" Share Class you will receive the same number of shares in the Receiving "(dist.)" Share Class. Any dividend earned in respect of that "(dist.)" Share Class, up to and including the Merger date, will be reinvested and you will receive additional shares in the Receiving "(dist.)" Share Class equivalent to the value of that dividend. For other Share Classes an exchange ratio will be applied to determine the number of shares allocated in the Receiving Share Classes. The exchange ratio will be rounded to 6 decimal places and you will receive the same value of shares subject to rounding differences. Details of the merger transactions, including the exchange ratio, will be issued within 10 business days.

The merging and receiving Share Classes are listed in Tables 1, 2 and 3 below.

You may want to review these options with your tax adviser and your financial adviser as there may be tax consequences.

German Shareholders: The Share Class merger is intended to be tax neutral in accordance with article 23 of the German Investment Tax Act.

The term "merger" used in this letter is to be understood in accordance with article 20 of the Articles of Incorporation of JPMorgan Liquidity Funds.
