On the merger date, the assets of the merging sub-fund will be transferred into your sub-fund. The merger will increase the assets under management of your sub-fund. There will be no rebalancing of your sub-fund and no costs associated with the merger will be borne by your sub-fund. When the merger transaction occurs, all the assets, liabilities and any accrued income in the merging sub-funds will be transferred to your sub-fund, and the merging sub-funds will cease to exist.
