Fund termination - option to take action ends 27th August 2019 at 12.00 noon

Reason for Termination Since the launch of the Fund in January 2014, its assets under management have not grown significantly. Following significant shareholder redemptions, the Fund's size has fallen to £12.7 million as at 24th June 2019, which is a size that is not commercially viable and we believe there is limited prospect of attracting new subscriptions in the future. We have therefore taken the decision to close the Fund.

YOUR OPTIONS
