Dear Investor,

On the 28 February 2022 the Authorised Corporate Director (ACD) communicated that we had taken the decision to suspend trading and calculation of the Net Asset Value (“NAV”) on the JPMorgan Fund ICVC - **JPM Emerging Europe Equity Fund**. This decision was taken in order to protect the best interests of shareholders in the Fund. As a result, the last official NAV/Price per share published was on the 25 February 2022.

There has been no significant change in market conditions and therefore the suspension remains in place for the **JPMorgan Emerging Europe Equity Fund**, we hereby provide an updated indicative NAV/Price of each share class as of **31 October 2022**.

An indicative NAV is an internal estimate of the value of the fund’s assets considering the investment manager’s inability to trade Russian assets both onshore and offshore, lack of relevant price discovery and market uncertainty. Please note this is not an official NAV/Price, the official NAV/Price calculation is still suspended, and you cannot subscribe or redeem from the Fund.

Please be aware the A share class was recently converted into the C share class and is now formally closed.

The Authorised Corporate Director (“ACD”) has recently mailed all shareholders in the Fund on the proposed next steps which it believes are in the best interests of shareholders to resume normal dealing in those liquid assets. The ACD’s proposal aims to segregate the liquid assets from the illiquid assets of the Fund by transferring the liquid assets, in specie, to a newly created Fund, namely, the JPMorgan Fund ICVC – JPM Emerging Europe Equity II Fund whilst retaining the illiquid assets within the current Fund

Shareholders should review the letter recently sent to understand the proposal in greater detail. However, the proposed action can only take place if sufficient shareholders vote in favour, so shareholder votes are important.
