

JPMorgan Investment Funds - Global Income Fund Global Income Conservative Fund

The prospectus has been updated to include updates to the Sub-Funds' 'expected range' of exposure to MBS/ABS:

- JPMorgan Investment Funds - Global Income Fund – 0-25% (previously 5-25%)
- JPMorgan Investment Funds - Global Income Conservative Fund – 0-45% (previously 15-45%)

The Investment Manager expects exposure to MBS/ABS to decrease over the long term and believes decreasing the lower end of the expected range to 0% would be more representative of the portfolio.

This is due in part to the decreased investable universe of MBS/ABS for the Sub-Funds. Furthermore, the Investment Manager is expected to increase its allocation to other asset classes, which offer an increasingly more favourable comparative risk-adjusted return.

There is no increase to the risk profile of the Sub-Funds.
