

Sustainable Finance Disclosure Regulation (SFDR) Categorisation as Article 8 under SFDR

JPMorgan Funds – Flexible Credit Fund

The prospectus of JPMorgan Funds has been updated to reflect that the JPMorgan Funds – Flexible Credit Fund has been re-categorised from Article 6 to Article 8 under SFDR.

The Sub-Fund has been classified as “ESG Promote” and the Sub-Fund Description has been updated to reflect this categorisation and the following binding criteria:

- At least 51% of assets are invested in issuers with positive environmental and/or social characteristics that follow good governance practices
- Specific values and norms based exclusions.

This update clarifies how the Sub-Fund is currently being managed and does not affect its risk profile.
