## JPMAM Commentary

Due to the diverse liquidity landscape across products in the fixed income universe prioritising execution factors on a generic basis is difficult. Couple that with the rationale or strategy that trades can be linked to compounds those issues further. Individual orders may differ with respect to the most important factor, for example some orders are time sensitive so speed of execution maybe be the primary factor, others may require use of balance sheet and as such certainty of execution may be the most important factor. However, as a general guide the below are the most important factors for deciding between execution venues.

1. Pricing
2. Liquidity relative to size
3. Premium/cost for increase in size
4. Consistency of counterparty service and willingness to offer balance sheet
5. Speed of execution

As part of our overall trading strategy we can execute trades directly with counterparties or via a multi-lateral trading facility (MTF). When executing on an MTF quotes are obtained from multiple counterparties in competition. Where an MTF (Bloomberg, Tradeweb) is included in the Top 5 venues above the trade will have been concluded with a broker-dealer rather than the MTF. The Top 5 broker dealers used during 2020 were:

1. Citigroup Global Markets Limited
2. Goldman Sachs International
3. Morgan Stanley & Co International PLC
4. Barclays Bank PLC
5. HSBC Bank PLC

For larger OTC orders which may have more limited liquidity it has been shown that the use of individual brokers is in the interests of our clients. The brokers that we have most frequently executed trades with directly are included in the Top 5 Venue table.

There is currently no consolidated tape data in fixed income markets and transparency varies across the spectrum of fixed income assets. We monitor hit ratios and dealer performance for all liquid markets utilising Tradeweb's Gold reporting functionality. This report in addition to internal tools allows us to confirm who is seeing and winning our business. We also utilise pricing statistics across various electronic crossing networks (ECNs) to assess the quality of pricing offered by our trading counterparties, taking into account ability to execute institutional sized trades that require inventory, liquidity provision and a history of quality execution/likelihood of execution of these larger sized orders.

We would however expect top tier counterparties to provide a high quality response rate to Request For Quotes (RFQ) on these platforms and we closely monitor trade data to ensure the level of service is maintained to a high standard. Tradeweb also provides transaction cost analysis reporting to enable us to confirm how much it costs to trade each market sector and maturity on Tradeweb ECN. The results of both internal and external reporting are regularly reviewed as part of our ongoing monitoring.
