

Straight Through Processing Guide

J.P. Morgan Global Liquidity offers a variety of Straight Through Processing (STP) options to ensure ease and accurate processing of trades, confirmations and payments. The different options include automated solutions such as SWIFT, File Transfer, Direct Debit and Morgan Money, which are briefly outlined in this guide.

SWIFT

SWIFT is a fully automated messaging system that enables connection between banks, corporations and trading platforms on a secure network. SWIFT can be used for trading and receipt of account reporting such as statement of transaction, monthly statement and daily balance report.
